Message from Nemaha County Hospital's CEO

Welcome to the 2020 Nemaha County Hospital Annual Report! This has been a year like no other any of us have experienced. Who would have thought that we would be dealing with a pandemic in this country at this time? And Nemaha County Hospital has been at the forefront of the action in this area from the start.

I was attending a conference in Kearney on March 2nd and had the opportunity to have dinner with Dr. Jeff Gold, Chancellor of both the University of Nebraska Medical Center and UNO. They had been caring for the positive cases of COVID-19 from the cruise ship and I knew that he, along with many others from UNMC, had a great deal of knowledge regarding this and other pandemics. We had a wonderful discussion that night and I left that dinner thinking that maybe we had a chance.

What we did was to prepare for the worst while hoping for the best. I was attending meetings in Lincoln on March 9th and 10th before everything shut down and when I got to work on the 11th, a team of hospital leaders and the Infection Prevention Committee had a plan in place. Basically, we would continue to operate as we had been until there had been a case identified in our area, defined as the area covered by the Southeast District Health Department, and then we would do what was identified in the plan in a phased approach. We said that our plan was written in pencil because it seemed that new information was made available requiring the plan to be updated on a daily basis.

On March 18th, we were informed that a gentleman in his 60s needed to be tested for COVID-19. We collected that test in our ambulance bay with the patient sitting in his car and the person collecting the test in full protective equipment. On March 19th we received word from public health that he had tested positive for COVID-19. If we had to have a positive case, this was the perfect one. This person contracted the disease out-of-state and had a pretty good idea what was wrong with him when he got home. He stayed at home and his wife stayed home so that the community was not exposed.

When the second case was discovered in the area in Otoe County on March 30th, we decided it was time to lock down the hospital and implement our plan for dealing with a pandemic. What happened next was pretty scary and somewhat risky. We essentially locked down the facility to only those that needed emergency or inpatient care. We canceled all of our outpatient specialty clinics. Any surgery that could wait was put on hold. Anyone needing therapy that could wait, waited. Anyone entering our facility was screened for a temperature and a history and symptoms of COVID-19. We had hardly any encounters with patients at all. What this really meant was that for all of April and the first two weeks of May our revenue was down by 80% and our expenses were essentially unchanged.

Around the middle of April the federal government started making relief money available for hospitals. We received our first stimulus check and then applied for accelerated payments from Medicare. We also applied for a Small Business Administration loan called the "Payroll Protection Program" to help pay for the salaries of our employees. It was technically a loan but it was forgivable if we met certain criteria, which we have met.

We have since received another stimulus check and a couple of small grants so we should be ok financially for the short term. On May 4th, when the governor gave the OK to partially open up, we were cautious and waited another week to begin offering more services. On May 11th we began having outpatient clinics and elective surgeries again. It was nice to have people back in our facility. We still did not allow any visitors in and everyone entering the facility had to be screened.

Wear a mask. Practice social distancing. Wash your hands. Protect yourself and others that you care for. This virus may mutate and go away, but it hasn't done so yet. My hope is that a vaccine will be available soon so that we can all become immune to the virus.

Thanks reading this update. Things will get back to normal, but it may take a while.


A Fresh Look for NCH

Supplying the Team

Central Supply is in charge of the Pay to Procure Cycle for Nemaha County Hospital. Our routine duties include working with our Group Purchasing Organization to ensure proper supply selection, sourcing supplies through vendors, receiving and distributing those supplies throughout the hospital and then matching invoices to the corresponding orders. Rural hospitals, like ours, face challenges such as keeping a lean inventory while maintaining proper supply selection and negotiating with vendors to break down large quantities of supplies into more manageable units of measure. We aim to keep quality high and cost low.

Navigating Central Supply during a Pandemic has brought us a number of challenges. The first situation we encountered was the disruption to available Personal Protective Equipment (PPE). Our Group Purchasing Organization re-routed the resources we normally receive, to hospitals all over the United States that were Covid-19 hot spots. We worked endlessly with our main supplier, Shared Service Systems (a Nebraska-based company), and the Southeast District Health Department to procure the supplies we needed for the Pandemic. Our community also contributed to our need by donating masks, Clorox wipes, and other disinfectants. The next issue to present was counterfeited PPE and hand sanitizer, which meant we were unable to go outside certified vendors to purchase these items. As we move forward, we have secured a safety stock of PPE and the challenge becomes how to utilize that stock. We keep track of the PPE we dispense and routinely evaluate the amount on hand against forecasted Covid-19 numbers to ensure that employees are adequately protected now and in the future. Additional Pandemic tasks included finding innovative ways to sanitize and re-use essential items, staying up to date on FDA requirements regarding acceptable types of PPE, and of course, buying enough Toilet Paper.





The Infection Prevention Team

Infection Prevention and Control (IPC) is the practice of preventing or stopping the spread of infections or diseases in healthcare facilities.

Starting in early March the Nemaha County Hospital IPC team worked closely with the CDC, Nebraska Department of Public Health and the Southeast Nebraska Health Department.

Our priorities included:

1) Rapid identification of suspected cases through screening and triage at the hospital entrances as well as limiting the entry of staff and visitors with suspected or confirmed cases of Covid-19.

2) Immediate isolation and referral for testing which includes a special negative pressure room for testing or treating suspected cases of Covid-19.

3) Immediate identification of inpatients and staff with suspected Covid-19. This included having policies and procedure in place that were fluid as the virus spread. Three tiers of action were produced based on the severity of the virus, from basic social distancing to closing of entrances. The tiers covered all areas of the hospital from staffing concerns, PPE, cleaning/disinfecting, outpatient services, therapy services, laboratory, radiology, surgery and anesthesia, home health, and meal preparation.

4) Adherence to the appropriate use of PPE, including the introduction and education of new equipment such as the Airvo #2 high flow oxygen and the review of proper technique in the use of PPE.

At one time, the likelihood of a pandemic, in some minds, was seen as a low risk, but now situations such as Covid-19 show the importance of healthcare preparations and plans for such situations.


Working Together to Continue to Improve Care



A Note from Courtney Upmann, PA-C


My name is Courtney Upmann, PA-C. I earned my undergraduate degree at Concordia University in Seward, NE, and my Master of Physician Assistant Studies (MPAS) at Union College in Lincoln. Some of you may have me if you're a patient in the ER, as an inpatient on the floor, or even in the outpatient clinic when I help out with stress tests. I have worked at Nemaha County Hospital, through the Auburn Family Health Center, for three years now. This is the first truly rural setting that I have worked in. It has been a great experience and everyone in the community has been very welcoming.

I have seen many examples of how all departments at Nemaha County Hospital and the community in Auburn pull together when we have a serious trauma or critical illness situation. Our unit coordinator activates the trauma team and sometimes, the rescue squad will stay and help if we have a code situation, or if there is a code in progress and CPR is needed.

Many departments in the hospital are called to help in these situations. Radiology and Lab Technicians are ready at any moment for traumas and their equipment is ready for whatever happens. They are also CPR certified and ready to step in if more people are needed to run the code. Our Respiratory Therapists also check in with the ER before they leave, making sure there is not anything they need to do before leaving. If needed, our pharmacists may help draw up the cardiac medications.

We also have our physicians from Auburn Family Health Center who are ready at a moment's notice. Sometimes they come over in the middle of clinic if they are needed for a situation. And of course, we have the excellently trained nurses that have to be ready for anything. They never know what their day is going to consist of but they come in every single day ready and prepared.

This is truly a team of coworkers and friends that must be ready for anything. We may have a day where we have few patients, or we may have a day where the rescue squad drops off a patient and immediately gets called to bring us another. We all have multiple roles to fill and we all work together at Nemaha County Hospital to provide excellent care as a team. Every single part of that team is important, and if we are missing one individual part, it simply does not work as well. I genuinely love my job at Nemaha County Hospital and caring for all the patients that make their way into our rural hospital.

Keeping It Together

Welcome to the Health Information Management Department (HIM)! Our department provides services to all the other departments in the hospital. We in the HIM department help improve the quality of healthcare by making sure that the best information is available for making any healthcare decision at the time and place of care. We are the "keepers" of all things! We ensure the confidentiality and protection of patient health information from the doctor's orders, dictation, and patient demographics to the final lab and x-ray results. We ensure the patient's right to privacy and secure and confidential information.

Currently we have 5 full-time employees in the HIM department. Melissa Mason, our newest member, is our Patient Services Representative here at NCH. Melissa is responsible for all preauthorizations/authorizations for all services throughout the hospital. Melissa will obtain advanced approval from the patient's health care plan before a specific procedure, service or medication is delivered to the patient to qualify for payment coverage.

Heather Koppelmann is our HIM Clerk. Heather is the friendly voice you will talk with if you are needing your medical records sent to another provider for further care or for your own personal use. Heather is responsible for the compiling, organizing and completeness of the patient's medical record. She is responsible for scanning test results and reports into the patient's records and analyzes the records for completion within 30 days.

Michelle Watkins is NCH's transcriptionist. Michelle is responsible for listening to voice recordings that physicians and other healthcare professionals make and she converts them into written reports. She also reviews and edits medical documents created by using speech recognition technology. Michelle is a walking dictionary with all her knowledge of medical terminology and abbreviations!

Trisha Kelsay is our outpatient and inpatient coder. Medical coding happens every time a patient is seen here at our facility for a test or service. Trisha ensures the codes are applied correctly during the billing process which includes abstracting the information from documentation, assigning the code and creating a claim to be paid by the insurance carriers.


Delivering Quality Inpatient Care 24/7



Nemaha County Hospital offers inhouse Advanced Trauma Life Support Certificated Physician Assistants 24/7. NCH offers 24-hour on-call physician coverage for emergency and trauma situations. NCH is designated as a "Basic Level Trauma Center" as part of the Nebraska Statewide Trauma System. We are equipped with a helipad for air transport and have easy access for ground transportation.

All of our Nursing Staff are trained in Basic Life Support (BLS). All Registered Nurses are trained in Advanced Cardiac Life Support (ACLS), and Trauma Nurse Core Course (TNCC). All Physician Assistants are trained in Pediatric Advanced Life Support (PALS).

Patient safety is a priority at Nemaha County Hospital. We use real-time documentation and electronic medication verification as one aspect of our safety initiatives. 




